Commissioner LaRocca made a motion for \$260 to purchase 6 stream light batteries, this was seconded by Commissioner Schmatz. All voted aye.

Commissioner Alongi made a motion for a 5 year Service Agreement with the Fire Company starting January 1, 2025, this was seconded by Commissioner Schmatz. All voted aye.

Commissioner Alongi stated that the medicals are going up \$5 for physicals and \$10 for DOT physical.

Commissioner Alongi submitted paperwork to the County regarding the election.

Commissioner Alongi is working on the DCRP paperwork for Commissioner LaRocca.

Commissioner Spector made a motion to continue our agreement with Holman as our auditors; this was seconded by Commissioner LaRocca. All voted aye.

Commissioner Spector stated that the Township would like to use our gas pumps while the pumps at the school are down. Would be for about 2 weeks and we would invoice them.
