The proposed 2021 is increasing by approximately \$30,000 or 1.6%. The major increases are professional fees, medical expenses, medical repairs and medical supplies. The major decrease is capital appropriations.

The board projects professional fees will increase \$5,000 (20.0%) due to increased election expenses.
The board projects medical fees will increase \$2,630 (19.0%) due to increased testing due to the pandemic.
The board projects radio maintenance and repairs will increase \$3,000 (20.0%) based on current year expenditures.
The board projects air pack / compressor service will increase \$3,000 (26.1%) due to aging of equipment.
The board projects medical supplies will increase \$3,665 (146.6%) due to pandemic personal protective equipment purchases.
Capital appropriations has decreased \$90,000 (52.9%).
Fund balance utilization has decreased \$100,000 (100.0%) to \$0.

The proposed 2021 budget will increase the amount to be raised by taxation \$30,001. This is an increase of 1.6%. The tax rate will remain unchanged at \$0.045 per \$100 of assessed property value. No unrestricted fund balance is being used in the proposed budget as the anticipated amount raised by taxation will fully cover the operation of the Fire District for the year. The 2021 budget is in compliance with the levy cap. The board did not need to utilize any of its Levy Cap Bank to comply with the Levy Cap requirements.




