The 2022 budget is increasing approximately \$43,900 (2.3%) from 2021. All revenue is derived from taxation, as in prior years. The tax rate is anticipated to increase from \$0.044 pre \$100 of assessed value to \$0.045 per \$100 of assessed value. Cost of administration, operations, and maintenance is anticipated to increase approximately \$44,900 (5.4%) from the prior year. The LOSAP contribution has increased approximately \$75,000 (30.3%) due to actuarial calculation of a short-fall in the defined benefit plan. Reserve for Future Capital Outlays has increased \$19,950 (24.9%) in anticipation of future capital needs. Debt service and related interest payments have decreased approximately \$90,100 (44.2%) and \$5,900 (13.2%), respectively, due to making the final payment on the pumper truck loan in 2021.

Fire hydrant rental fee is increasing approximately \$29,800 (10.0%) due to an increase in the utility contract fee in 2022. Vehicle maintenance is anticipated to increase approximately \$10,000 (20.4%) due to the aging of the vehicles and increasing costs. LOSAP contribution is anticipated to increase approximately \$75,000 (30.3%) due to actuarial calculation of a short-fall in the defined benefit plan. Reserve for Future Capital Outlays is increasing \$19,950 (24.9%) in anticipation of future capital needs. Debt Service payments are decreasing approximately \$90,100 (44.2%) due to the final payment on the pumper truck being paid in 2021. Interest Payments on Debt Service are decreasing approximately \$5,900 (13.2%) due to the final payment on the pumper truck being paid in 2021.

The amount to be raised by taxation is anticipated to increase approximately \$43,920 (2.3%). This will increase the tax rate from \$0.044 per \$100 of assessed value to \$0.045 per \$100 of assessed value.

The board has designated \$99,950 for Future Capital Outlays in the 2022 budget. This is an increase of \$19,950 (24.9%) from the 2021 budget. This is in anticipation of future purchases as equipment ages.
Debt Service is approximately \$113,600 in the 2022 budget. This is a decrease of approximately \$90,100 (44.2%) from the 2021 budget and is the result of the final payment being made on the purchase of a pumper truck during 2021.
Interest Payments on Debt Service are approximately \$38,400 in the 2022 budget. This is a decrease of approximately \$5,900 (13.2%) from the 2021 budget and is the result of the final payment being made on the the purchase of a pumper truck during 2021.
